Gentlemen:

In conjunction with the introduction of the new SAP business systems, the Company proposes to eliminate dual classification positions, impacting approximately 85 employees currently in dual positions. The Company has determined that the wage administration for dual classification positions which results in employees being paid for the classification worked that day has significant administrative costs associated with it which are compounded with the transition to the SAP business systems.

Company proposes that each headquarters with a dual classification position may reclassify the position and incumbent employee to the primary (first listed) classification, provided that the incumbent has worked at least 50% of the time in the primary classification during the past 6 months, or they may be reclassified into one of the new or existing combined classifications noted below:

Classification Code	Classification	Title

2770	Credit Representative and Meter Reader	(existing classification)
2772	Meter Reader and Utility Clerk	(new classification)
2769	Service Representative and Meter Reader	(new classification)

In the event that a headquarters has multiple employees in the same dual classification (e.g. Utility Clerk/Meter Reader), each of whom has worked at least 50% of the time in the same primary classification during the past 6 months, the Company will offer reclassified positions to employees by seniority (e.g. If Concord has two Utility Clerk/Meter Reader positions and reclassifies one position to a Utility Clerk and the other to a Meter Reader and Utility Clerk, the senior of the two employees may choose which position to take.).

Employees placed in the above classifications would receive the wage rate of the higher of the two combined classifications, regardless of the duties assigned. All of the employees currently in a dual classifications are working in one of the combined classifications noted above, except for two employees working as Cableman/Cable Splicer in San Francisco Division. Company proposes to reclassify these two employees as Utility Cableman, Classification Code 0141. As Utility Cableman, the Company could assign them to perform work as Cableman or Cable Splicers on any given day. They would receive the Cableman rate of pay when performing Cableman or Cable Splicer duties.

This letter is intended to delete all sections of the Clerical and Physical Agreements dealing with dual classification positions, including the following sections.
