**Gentlemen:**

**As the result of the cancellation of Letter Agreement R2-92-141-PGE, Company proposes pursuant to Section 204.4 of the Agreement to establish the classification of 0547 Shift Firewatch - DCPD at the Diablo Canyon Power Plant. A job description and wage schedule is included as Attachment A.**

**Further, Company proposes that:**

- 1. The physical pre-employment test will be a requirement for entry to the Firewatch classification.**
- 2. The department of "Firewatch" will be established and utilized to determine the applicability of "department" as stated in Letter Agreement 88-104.**
- 3. The following numbers will be added to the 88-104 headcount floor number:  
Firewatch - 10; Mechanical Maintenance + 9; Building Services +1.**

4. Utility Worker 0940 and 0963 will be modified to provide Priority 1 Transfer Rights for 0547 Shift Firewatch - DCPD (Relief).

**0547 SHIFT FIREWATCH - DCP (Relief)**

Performs roving firewatch patrol and checks known impairments. Reports new impairments immediately. Performs inspections of fire suppression systems such as fire barriers, fire valves, fire extinguishers, emergency battery operated lights. Performs inspections of safety, eyewash and shower stations, and first-aid kits. Performs routine tests on fire detection systems. Checks hotwork locations for appropriate hotwork permits. Performs stationary firewatch duties as assigned. May also be assigned to the Fire Brigade.
