The unresolved issue in this case is one of whether the Union's member of the expanded Local Investigating Committee is entitled to overtime compensation for time spent investigating a grievance, pursuant to Title 102 of the Agreement and the supplemental grievance procedure. The contract provides for Union's member of the Local Investigating Committee to be allowed time off with pay to the extent that if necessary for carrying out his responsibilities as a Committee member. In the opinion of the Pre-Review Committee, Section 102.3 of the Agreement provides only for payment during an employee's regular work hours and does not provide for overtime compensation. As to the scheduling of Local Investigating Committee meetings, the parties should, if possible, attempt to arrange the meetings in such a manner as to avoid disruptions to <u>all</u> parties concerned.

When a settlement is reached by the Joint Grievance Committee, the Review Committee should be sent a copy of the final disposition.
