Prearranged Overtime, Machinist

MR. D. W. PHIPPS, Chairman Coast Valleys Division Joint Grievance Committee

The Pre-Review Committee has discussed the above-subject grievance and is returning it to the Joint Grievance Committee requesting the following information:

- 1. The prearranged overtime hours worked by all Machinists at Morro Bay Power Plant at the time of the grievance and currently.
- 2. In the application of Section 208.16, are employees charged as if they worked if they turn down prearranged overtime assignments?
- 3. In view of the fact that the Machinist classification has been designated as a traveling classification, are the prearranged overtime hours worked as a result of traveling assignments computed in the accounting period; and if so, how can equitable distribution prearranged overtime be accomplished when the Plant has very little control?
- 4. When did supervision determine that a Machinist would be assigned this work; and were any allowances made to hold Mr. Keltner back an equivalent amount of prearranged overtime as a result of this assignment?

After the investigation has been completed, the Committee should attempt to resolve the case; if not, the case should be returned to the Review Committee accompanied by a written report of the Committee's findings and reasons why the issue could not be resolved.
