The above-subject grievance has been discussed by the Pre-Review Committee prior to its docketing on the agenda of the Review Committee and is being returned, pursuant to Section IB(2) of the Review Committee procedure, to the Local Investigating Committee for settlement in accordance with the following:

This case involves the claim by a number of employees in the Shop Section of the Materials Distribution Department in Emeryville that they had a number of tools stolen on February 2, 1979. They requested reimbursement of these tools under Section 107.3(b) of the Physical Contract, and the claim was denied by the Company.

The Committee notes that the list of tools contained in the Joint Statement of Facts includes some which are on the approved list and others which are not. The Committee further notes that the Local Investigating Committee was unable to determine any physical evidence of the theft. However, testimony by the various employees involved was that each were missing a number of tools, which tools are normally kept in a room with a locked door. Although the employees have tool boxes which lock, these tools apparently were not kept in the tools boxes since the security of the locked room has apparently in the past provided sufficient security.

In order for the Committee to resolve this case, it needs further information from the Local Investigating Committee. Such information is, of the tools noted in the Statement of Facts which are on the approved list:

- 1. How many of these tools were replaced by the employees?
- 2. Obtain copies of dated receipts for such tools as were replaced.


