The above-subject grievance has been discussed by the Pre-Review Committee prior to its docketing on the agenda of the Review Committee and is being returned, pursuant to Step Five A(ii) of the grievance procedure to the Local Investigating Committee in accordance with the following:

The question of reclassifying System Operators at Potrero Substation from System Operator No. 3 to No. 4 was a product of the Rerate Negotiations that were concluded in July of 1979. At this time, the Rerate Committee is again meeting and the Pre-Review Committee is of the opinion that this issue would be better resolved by that Committee and, therefore, agrees to submit the issue for their consideration.

Once a settlement has been reached by the Rerate Committee, the Joint Grievance Committee will be notified of their results.
