The above-subject grievance has been discussed by the Pre-Review Committee prior to its docketing on the agenda of the Review Committee and is being returned, pursuant to Step Five A(ii) of the grievance procedure, to the Local Investigating Committee for settlement in accordance with the following:

The issue in this case is almost identical to the one recently resolved in Pre-Review Committee Case No. 585. The difference here is that a Utility Clerk in the Monterey District Gas Department had submitted prebids to the position of Service Representative in the District's Customer Service Department. In mid-August 1980, the Company rejected her bids as being out of the Line of Progression. The discussion provided in Pre-Review Committee Case No. 585 is directly applicable to this case. As a result, the Committee agrees that, since the implementation of Title 18 of the new Agreement was effective on June 1, 1980, the Pre-Review Committee agrees that the return of the grievant's prebids in mid-August 1980 was not in violation of the Labor Agreement.

This case is considered closed on the basis of the foregoing, and the closure should be so noted by the Local Investigating Committee.
