


The above-subject grievance has been discussed by the Pre-Review Committee prior to its docketing on the agenda of the Review Committee and is being returned, pursuant to Step Five A(ii) of the grievance procedure, to the Joint Grievance Committee for settlement in accordance with the following:

This grievance concerns the transportation and/or mileage allowance for special assignment of six General Construction Painters. The six grievants were assigned to Colfax on October 31, 1980 and given a Company vehicle for transportation from the Geysers to Colfax. Grievant Mitchell was assigned to drive the Company vehicle. The other five Painters elected to drive their own vehicles and are requesting that they be reimbursed for their transportation expenses. The Pre-Review Committee is not in total agreement as to whether or not the provisions of 301.11 of the Agreement were met, albeit Company transportation was authorized, there seems to be a question of whether it was adequate. Therefore, the Pre-Review Committee is of the opinion that an equity settlement is called for; and to that end, agree that the five grievants who provided their own transportation be paid expenses, under Section 301.11, one way.

This case is considered closed on the basis of the foregoing and the adjustments provided herein, and the closure so noted in the Minutes of your next Joint Grievance Committee meeting.
