Subject of the Grievance:

This case concerned the distribution of prearranged overtime at Diablo Canyon Power Plant in the Operations Department for 1986. The case was one of several addressed in a Pre-Review Committee Decision dated May 29, 1989. The determination of any liability and resolution was remanded to the Local Investigating Committee with the Pre-Review Committee retaining jurisdiction if agreement was not reached locally.

Facts of the Case:

The Local Investigating Committee returned this case to the Pre-Review Committee in May 1991.

After much discussion about whether relief employees should be included in the equitable distribution of prearranged overtime with non-relief employees for those assignments not involving the filling of a vacant shift, it was determined that this is no longer an issue because there are no longer any relief operators at Diablo Canyon Power Plant. The reliefs were eliminated when 12 hour shifts were established.

Therefore, the Pre-Review Committee agrees to the following equity settlement without prejudice to the position of either party:
