CASE SUBJECT:

LOGGED AND FILED RECEIVED OCT 2 6 1992

This case concerns the Company's utilization of a G.C. crew in lieu of the Division employees who had signed the headquarters 212 list for an emergency assignment.

CASE FACTS:

- 1. A G.C. Crew consisting of seven employees was called to respond to an emergency.
- 2. The G.C. Crew could respond quicker than the Division, in this case, given their location and weather conditions.
- 3. Two Division employees, a lineman and a crew foreman, were signed on the Division 212 list and were not called.
- 4. The work in question took 6 1/2 hours to complete.

DISCUSSION:

The committee agreed that supplementing a G.C. crew with Division employees is not normally done except in an all hands situation. The Committee also discussed the G.C. Foreman's contribution to the expeditious restoration of service and the Division employees availability for overtime.

SETTLEMENT:

Given the specific facts of this case, the Committee agreed to an equity settlement of 6 1/2 hours at the double time rate to be paid to the Lineman signed up on the Division 212 list. The Committee agrees given that the majority of the employees in any case would have been G.C. and in consideration of the particular contributions of the G.C. Foreman, the Division Crew Foreman will receive no payment.

This case is closed without prejudice to the position of either party.
