

In accordance with the remedy reached in Arbitration 184 to settle this grievance; retroactive to 30 days prior to the filing of the grievance, the Company will pay the difference in wages to the Fieldman who would have received the upgrade, but for the use of the contract Backhoe services. Company will reimburse the Union for retroactive union dues and pay the difference between those wages paid to the contract Backhoe Operators and the Equipment Operators rate to eligible contract Backhoe Operators.


On this basis, this grievance is closed.


