The Pre-Review Committee discussed this case on November 5, 1992. The Committee believes that since the Construction Supervisor knew that a 1-1/4" cast iron regulator was needed, it would have been logical for the supervisor to try and obtain information on the number of meters and meter size.

The Pre-Review Committee believes that the Construction Supervisor should have tried to obtain this information from the service tag or customer information records. If the service tag or available customer records were available to the supervisor and the meter size or number of meters indicate that a Gas Crew Foreman should have been called, the Pre-Review Committee believes that the grievant was inappropriately bypassed for the overtime assignment.

The Pre-Review Committee is returning this case to the Local Investigating Committee with instructions to settle the case based on the above guidance. The Pre-Review Committee maintains jurisdiction over this case if the Local Investigating Committee is unable to reach agreement.

The Local Investigating Committee is requested to send a copy of their settlement to the Pre-Review Committee so that the P-RC files reflect that this grievance has been closed.
