This letter supplements our letter agreement dated September 15, 1971 on the same subject.

1. Lines of Progression

The following classifications will be considered the same or higher classifications to Reserve Gas Serviceman:

0190 Chartman

0524 Fieldman

0810 Service Subforeman

1030 Test Inspector

1405 Service Mechanic

1483 Field Meterman

1755 Service Operator

2185 Air Conditioning Serviceman

2210 Serviceman

2230 Reserve Gas Serviceman

2230 Reserve Gas Serviceman shall be considered as the only next lower classification to 1755 Service Operator.

2. Reclassifications to Reserve Gas Serviceman

- a) The Company will reclassify, effective November 15, 1971, to Reserve Gas Serviceman all employees classified as Helper (Gas T&D 0930) on November 14, 1971, who have successfully completed the Gas Serviceman's training course, and who are qualified to perform the duties of Serviceman, and who are willing to accept such reclassification. Each employee who is so reclassified will be given credit for wage progression in the Reserve Gas Serviceman classification for time worked as a Serviceman on either a temporary or regular basis.
- b) The Company will also reclassify to Reserve Gas Serviceman, upon their

return to their Divisions, those employees who are currently attending the Gas Serviceman's training course and who successfully complete such course.

c) Each employee who is reclassified as provided in (a) or (b) above shall, for the purpose of bidding to a future Serviceman vacancy, be considered as being at the top of the rate of Reserve Gas Serviceman as of November 15, 1971. Time worked in the following classifications shall be considered as time worked in the next lower, same, or higher classifications to Serviceman:

0190 Chartman (See footnote of page 20 of Exhibit VI as revised 7/1/67)

0810 Service Subforeman

0930 Helper (Steam Heat or Gas T&D)

0933 Helper (Gas Meter Shop)

0934 Helper (Gas Plant Maintenance)

0950 Shift Helper (Gas Plant)

1030 Test Inspector

1405 Service Mechanic

Service 1755 % k x Operator (If he has previously qualified as a Serviceman)

2185 Air Conditioning Serviceman

2210 Serviceman

2230 Reserve Gas Serviceman

d) Company will prepare a list of the employees in each Division who are reclassified as provided in (a) and (b) above and shall indicate their classification seniority date for purposes of promotion to Serviceman. The Business Representative assigned to each Division will be provided a copy of the list.

3. Assigning Future Vacancies

Future vacancies which occur in the Reserve Gas Serviceman classification will be filled in accordance with the provisions of Title 205 "Job Bidding and Promotion" of the Agreement dated September 1, 1952. Future bidders on such vacancies will be required to successfully complete the Gas Serviceman's training course before being assigned to this classification in accordance with the provisions of Section 205.11 of the Agreement.
