The above-subject grievance has been discussed by the Review Committee and is being returned to the Division for settlement in accordance with the following:



# 8-75-11 Alleged Violation of the Provisions of Title 10, Hours, of the Current Clerical Labor Agreement.

### Union Position

Union contends in this case that Company's unilateral action to modify the hours of work for employees in the Customer Services Department in San Jose is in violation of the Hours Provisions of the current Clerical Labor Agreement.

#### Company Position

Company contends in this case that the provisions of Title 10 of the current Clerical Labor Agreement provide Company the flexibility of modifying the hours of work for public contact employees in order to maintain adequate public utility service.

## Disposition

The members of the Division Joint Grievance Committee agree to refer this grievance back to the Local Investigating Committee for disposition pursuant to the provisions outlined in the recently agreed to clarification of Title 10, Hours, and the guidelines to be provided by the Review Committee as they settle parallel issues currently on their agenda.
