

DECISION LETTER DECISION PRE-REVIEW REFERRAL

Nuclear Plant Operations Grievance No. 18-673-82-10 Review Committee File No. 1551-83-4

Subject of the Grievance

This grievance concerns the claim that the grievant, a Routine Plant Clerk, was performing duties that are normally assigned to a higher classification.

Facts of the Case

The grievant, a Routine Plant Clerk, claims that she is working unsupervised, has developed work procedures and operates the word processing equipment at Diablo Canyon Power Plant. The Union Committee members believe that this work is beyond that of the classification of Routine Plant Clerk and should be assigned to a Senior Plant Clerk. The Company Committee members believe that this work does not fall into the classifications of Routine Plant Clerk, Senior Plant Clerk or First Plant Clerk; and the work is currently being performed by Utility Clerks of the Clerical bargaining unit in other Departments and in the Divisions.

Decision

After some discussion, the Committee agreed that upcoming contract negotiations is a more appropriate forum to resolve this grievance. With this in mind, this issue should be referred to General Negotiations so serious consideration can be given to establishing a new classification whose duties would encompass the work identified in this case. Should the 1983 Negotiating Committe be unable or unwilling to provide a resolution to this case, it shall be returned to this committee.
