This case concerned the demotion of a Field Regulator Changer to a Helper when his California Driver's License was temporarily suspended for medical reasons. The Pre-Review Committee agreed that the demotion was for just and sufficient cause.

However, an ancillary question arose concerning whether grievant had preferential (306.9) rights to return to the Field Regulator Changer. This issue was referred to an Ad Hoc Negotiating Committee. The attached letter agreement 85-7-PGE resolved the question.
