At the Ad Hoc Committee's direction, these cases are returned to the Local Investigating Committee to determine if any liability exists based on the guidelines established in the Ad Hoc settlement. If the Local Investigating Committee is unable to agree, the Review Committee retains jurisdiction. If the Local Investigating Committee reaches agreement, the cases will be considered closed.
