## **Assistant Director Position Opening**

California-Nevada JATC is currently seeking experienced qualified Journeyman Linemen for an **Assistant Director** opening at our Woodland, CA facility. We are looking for an enthusiastic, energetic individual interested in the training, instruction and certification of apprentices, journeyman and other industry classification workers.

This full time position will be located in the Woodland, CA office, but travel throughout the geographical area of the program may be required for both crew visits and instructional training. The ideal candidate will be comfortable working in a variety of situations, both on the jobsite and at the administrative level, as well as with the Committees and training partners of the California-Nevada JATC. The selected candidate must be willing to work a flexible schedule. They will also be required to train and prepare for the position for approximately 3 months at our Riverside Facility in the beginning of January 2021.

The successful candidate will work with the Director and staff in the area of apprentice management to ensure successful completion of on the job training and related instructional training. Participation and/or instruction in the classroom (both with and without the assistance of other Journeyman) is required. Candidate will also be teaching related industry courses (First Aid/CPR, OSHA-10, Transformer Review, Rigging & Signalperson) as well.

*\*Candidates not having current trainer status for these courses may still be considered but will be required to obtain trainer status.*

### **The successful selected candidate should meet the following basics:**

- \* IBEW Journeyman Lineman
- \*Self-starting motivational personality with the ability to bring and maintain a positive attitude.
- \*Have a strong desire to teach and mentor students with the ability to make learning fun and interesting.
- \*Ability to clearly communicate verbally and written in a professional manner with colleagues, students, and staff
- \*Proficient in PC software applications including Windows applications, video files and the ability to learn the apprentice tracking software.
- \*Can Modify/Develop training materials
- \*Familiar with OSHA regulations
- \*Able to perform the physical requirements of the trade, ie. climb poles and towers, operate digger derrick, etc.
- \*Able to present new ideas and methods as well as support tried-and-true methods.
- \*Prior experience teaching apprentices both on the job and in the classroom is preferred but not required.
- \*Take direction and other job assignments as given by the Training Director of the California-Nevada JATC
