AS LAWFUL CONSIDERATION of being permitted to enter upon the premises of LINC RAAHAUGE'S HUNTING CLUB to participate in or observe activities or other use of the facilities, I/we the Undersigned, for my/our heirs, distributes, guardians, legal representatives, next of kin and assigns:
